3. Refer to Page 2 of 5 of the Bid Form. Eliminate the reference to AIA Form A305 for Contractor's Qualifications and use the attached form.

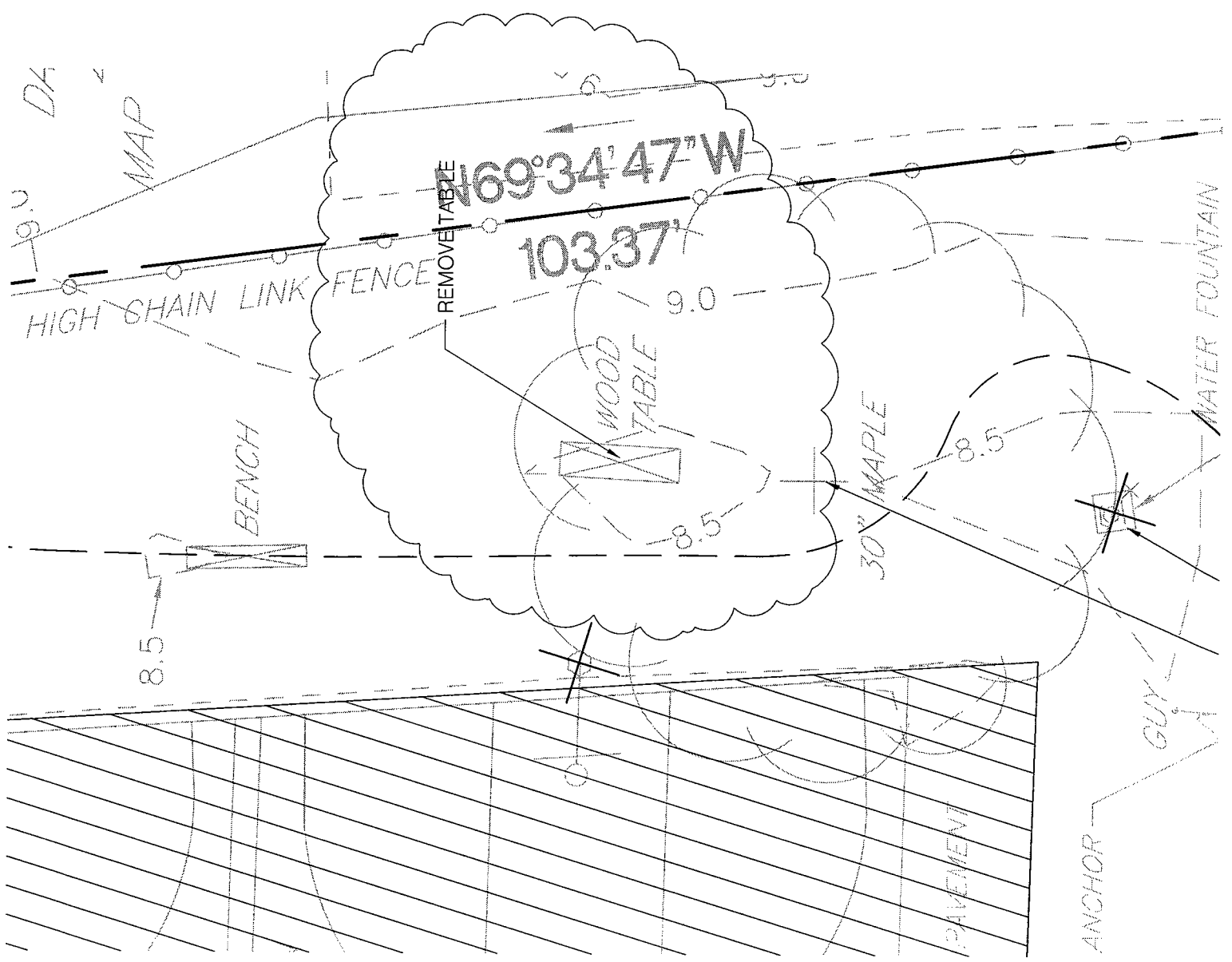

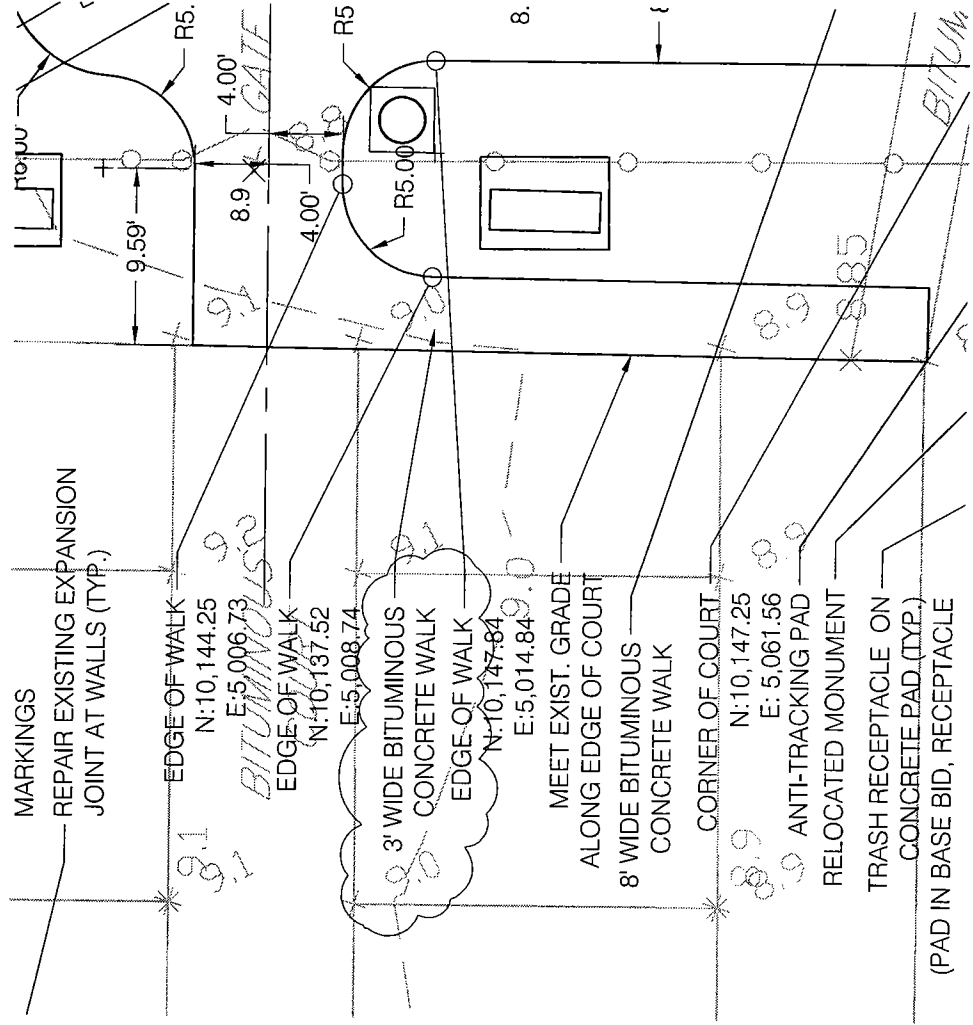
